

John Burton Hotchkiss

Quote: ..."the deaf teacher has from the start special knowledge of the peculiar difficulties of acquiring language through the eye along which it takes the hearing teacher years to acquire, if he acquires it at all...(the Deaf child) can easily see the possibilities of his own development and is thereby encouraged to effort and prevented from being quickly discouraged by failure..." Beloved Professor at Gallaudet College (University)

One of the founders and editors of the Silent World (DC)

Editor of Alumni Corner of the Buff and Blue

First president of the Gallaudet Alumni Association

Football Coach at Gallaudet College (University)

1924: Gallaudet College names its athletic field in his honor

Involved with NAD as signed interpreter/translator of presentations (1889) and on the Committee on Eugenics, Endowment Committee, the Hartford Monument Committee and others.

American School for the Deaf, graduating 1865

1865-1869: Gallaudet College (BA)

1874: Gallaudet College (MA)

1904: Gallaudet College (Honorary Doctoral degree)

Professional Experiences:

Began as a tutor after graduation and became English, Philosophy and History

professor at Gallaudet (staring in 1887)—worked for 53 years at Gallaudet National Deaf Mute College (Gallaudet University)

Personal information:

1887: Married Marian Chadwick (Hearing) from Salem, MA had two daughters, Helen (born: 1893) and one who died in infancy. As well as John B. Hotchkiss Jr (born: 1888)



John Burton Hotchkiss learned in its purity the language of signs, the heritance of the Hartford School from France, as taught at the School by Laurent Clerc. This language he in turn bequeathed to generation after generation of students who flocked to Gallaudet. These signs, correct in etymology and sanctioned by tradition, the popils of the Doctor tuok with them to give pleasure and profit to themselves and the deaf among whom they worked. Thus every gathering place of the Deaf in America felt Dr. Hotchkiss' teaching.
